Members agree to abide by The Right to Choose Healthy Food Club's Constitution, By-Laws and Code of Ethics. Members further state and agree that:

You are not planning to entrap, hurt, prosecute or otherwise gather information for any agency, corporation, or other entity to in any way negatively affect The Right to Choose Healthy Food Club, its Members, Member Farmers or its functions.

You are not aware of any medical conditions that would prevent you or your family from eating unprocessed or natural foods, including but not limited to **raw dairy products, range/grass fed meats or organically raised fruits and vegetables.**

You have personally researched the use and consumption of unprocessed or natural foods including but not limited to raw dairy products, range fed meats or organically raised fruits and vegetables and you understand that there are potential risks and benefits associated and attributed to cooking with and eating unprocessed and natural foods including but not limited to raw dairy products, range/grass fed meats and organic fruits and vegetables.

You fully indemnify and hold harmless of any wrongdoing and damages The Right to Choose Healthy Food Club, its Organizers, Members, Members Guests, Board of Directors and Member Farmers should anything arise that is or could be attributed to any of the above mentioned parties. You understand and agree that **The Right to Choose Healthy Food Club** is a private, Members only organization that is not engaged in the conduct of any trade or business, commerce transactions.

IMPORTANT PROCEDURES

- You **MUST pick up your goods within 2-3 hours** of delivery which occurs every other Monday sometime between 10am-Noon in Miami or Noon-3pm in Plantation. See our calendar.
- You will be notified by email and optional text message on Monday morning of delivery with a more exact time frame when truck is arriving.
- If you cannot pick up your goods, you may call Esquire Express in Miami to have them delivered to you for apx \$20-\$25 for within Miami. **Call Esquire: (305) 530-9580.**
- **A check** payment for foods purchased must be **provided at time of pickup.** Check to "Amos Miller". If unable, you must mail it to Donna (not the farm) the same day you received your goods (she will email you the address where to send your check – not the farm address).
- Order deadline is at 8pm every other Monday. (See schedule at www.MillersOrganicFarm.com). Email reminders are sent if you subscribe to the newsletter. If you miss the order deadline, there is a fee to submit a late order. Submit it online and we'll call it into the farm (if not too late).
